- 6. The license may be cancelled or suspended at any time by the Licensing Authority or by the Commissioner of Prohibition and Excise.
- 7. The licensee shall follow any general rules or orders, which may from time to time be prescribed under the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937).
