CONDITIONS.

1. The licensee shall be bound by the provisions of the Tamil Nadu Neera Rules, 2017.
2. The quantities of Neera procured and processed in a month / quarter or in a year shall not exceed the quantities mentioned above.
3. Any breach of the conditions of license or rules or orders either by the licensee or any person in their employment shall entail the cancellation or suspension of the license under Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937).
4. No fermented juice shall be manufactured from Neera drawn by the licensee.
5. If a licensee wishes to transport the Neera-fresh juice, they should apply for permit in Form-V.
6. The license may be cancelled or suspended at any time by the Licensing Authority or by the Commissioner of Prohibition and Excise.
7. The licensee shall follow any general rules or orders, which may from time to time be prescribed under the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937).
8. Any breach of the conditions of license or rules or orders either by the licensee or any person in their employment shall entail the cancellation or suspension of the license under Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937).
